## 1 Minutes of Meeting on 7 July 2015

## 2 Plan

2.1 The meeting discussed the topics identified in the Agenda as follows, so that members of the Committee can volunteer to work on each topic.

ACTION: All members of Committee to consider which of these topics they can volunteer to help with.

## (a) Drafting / restructuring

- 2.2 Ellen will keep carriage of the master draft.
- (b) Projects (including priority and delivery method)
- 2.3 Volunteers so far: Grace and Kelly. Grace mentioned that she thinks that Kay will also be able and keen to volunteer on this.
- 2.4 Agreed that all projects and any further projects that may be identified should be kept in the Plan document, but clearly identified in some way as projects rather than core planning matters. The West Hampstead plan has some useful tips for presentation.
- (c) Evidence (gathering and referencing in the plan)
- 2.5 It is hoped that Adam Brown from Planning Aid will be able to provide some assistance on this.
- (d) Graphics (maps, charts, photos, etc.)
- 2.6 Some time is available from a designer, that has been paid for in advance.
- 2.7 Agreed that photos will enhance the appearance of the Plan. Committee members to take photos around the area, and then the Committee will pick the most suitable ones for inclusion.
- 2.8 Grace volunteered to make notes of how the Plan may benefit from captions, graphics, etc.
- (e) Identification of views to be protected and

Identification of open spaces to be protected

- (h) Review of potential development sites (i.e. those not already identified in the plan)

- 2.13 Agreed that the Plan cannot ignore certain obvious sites, eg Murphys. May also need to consider sites where there are already buildings and which may be potential re-development sites.
